# CAMRA — THE BIGGEST PAIN IN THE ARSE

This was the message arising from a 'News Target' investigation published in local give-away papers like the "Putney Chronicle" towards the end of 1984. It comes from a London pub gov'nor, speaking anonymously, who said

*"Some governors put all the old slops back that have been hanging around in the bar for hours, but I don't agree with that. You can put a couple of gallons of water in the barrel and nobody will notice.*

*"You can put two gallons of water in 22 gallons of beer without risk - that's £16.*

*"The gain is £16 for every bucket of beer in one session and that's £32 a day seven days a week.*

*"But you can do your trade in if you are not careful because some people like the CAMRA mob can tell the difference between a good pint and a bad one.*

*"In fact they are the biggest pain in the arse you have ever come across to be quite honest.*

*"The normal average person can't tell the difference."*

The Putney Chronicle, part of the London & Westminster Group, describes what's going on as a "multi-million pound swindle" and has passed its findings to a London MP for action in Parliament.

Geoff Fish from Hammersmith environmental services said that he had heard complaints for over seven years about greedy landlords putting waste beer, slops and water into barrels for resale. He particularly pointed out that recycling the dregs from 'dead' glasses carries quite a health risk both from saliva and from contamination if the last 'user' didn't wash his hands after using the toilet. The same applies to slops from the drip tray if they have run down the side of a used glass on the way from the tap.

Also quoted was the West Midlands council consumer services department. They call for more information from brewers on original gravities to aid analysis and point out that chemistry cannot detect slops because the beer undergoes no change when they go in. Equally, up to 10% water can be added without being detected by present methods.

Keeg beer and lager isn't safe either. Despite the kegs carrying enough pressure to "blow your head off" unscrupulous landlords use keys and industrial wrenches called 'Stillsons' to get into them so as to add slops and water. "If you know what you're doing it's a simple job", said the landlord quoted above.



In some pubs the staff are unwittingly drawn in. The governor will tell some staff to do some things and some to do others. None of them sees the whole process.

The Chronicle also reported that the brewers neither encourage nor discourage the practise. They describe it as an "open secret" amongst both publicans and brewers.

Their investigations took several months and echo London Drinker's own reports on slop recycling. We fully support the efforts being made to stop this sort of thing.

There are of course many landlords who will have nothing to do with it. They aim to be honest with their customers and take pride in their beer. We support them and hope they prosper. As for the others, we'd hope that the drinker will vote with his feet and keep well away.

## OVER THE TOP?

In our last issue we featured the case of a man who had too much and by way of a follow up, it is instructive to point out that a landlord beside having the right to refuse service to someone who has had too many, also has a duty not to serve alcohol to someone who would as a result be incapable of looking after himself, PROVIDED that he knows this or should know. But don't rush out to sue the gov'nor next time you come home from the pub with a hangover. A legal case last year held that the licensee was not liable in the case of a drunken customer who had been asked to leave but fell to his death down a cliff on the way home, after climbing a fence without realising what was on the other side. The sort of situation that is worth avoiding, in other words.
