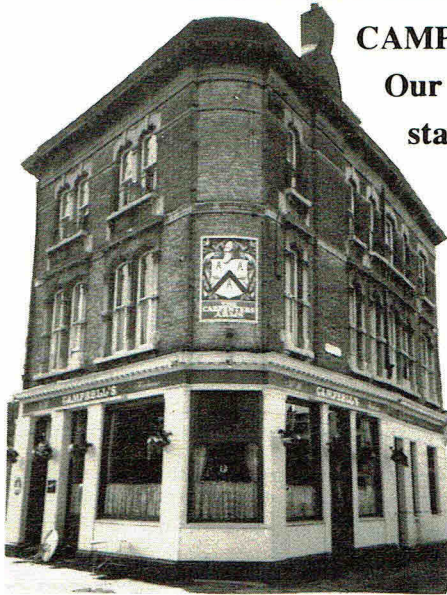

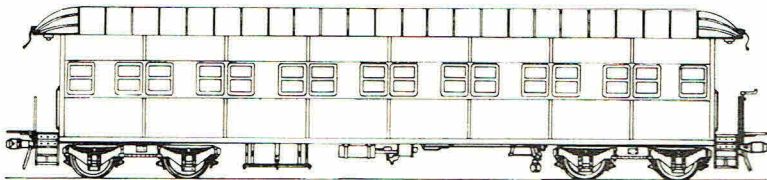

## GUEST EDITORIAL

For some time now misgivings have been expressed about the sales of alcoholic drink in off-licences. This does not refer to the traditional pub off-licence but rather to the supermarkets, corner shops and petrol stations that have cashed-in on this booming bonanza.

Since the passing of the 1961 Licensing Act, off-licences have increased by over 60% whilst full on-licensed premises have fallen by nearly 10%. If this trend continues, then the future of the pub as a local community centre could be in grave difficulty. Most of us would agree that the amendments to the licensing laws in the early sixties were welcomed by a great number of people since they offered easier access to sales of drinks, and also offered the prospect of healthy brewery competition. Experience has, however, shown that exploitation has damaged not merely the facility itself but also the accepted codes of competitive practice and social responsibility. This in turn has led to (a) unfair competition and (b) alcohol abuse, both of which have a detrimental affect on the traditional public house and its customer. The big brewery combines can, once again, be seen in their true colours of (a) financial muscle and (b) total disregard for public interest. Huge discounts are offered for goods supplied which leaves no possible margin for competition by the smaller independent brewer. Backed, of course, by massive advertising! And what do the public get - A neatly packaged bundle of characterless canned crap! For this little bundle of fun the tier public house has to pay the bill by way of ever-recurring price increases.

In addition to this grossly unfair competition, off-licences may trade from early morning to 11pm without an afternoon break. Some

disregard the law and sell drink even later. And in supermarkets there is no supervision on the sales of alcohol as there is in public houses. Are we supposed to call this "fair" competition? No wonder the off-licence market is booming, with financial incentives such as these and with little or no restrictions. Why can't public houses be treated similarly? And as for sales of drink in petrol stations, how insane can you get? Who will be first with the slogan "Get a tiger in your can . . . and arrive home DEAD on time!"?

On the social abuse side, there is:

(a) increasing evidence of alcoholism arising from drinking in the home. These statistics are fed into the national network of alcohol abuse and used by the temperance societies as a means of denigrating the public houses. And (b) we have all seen or read about football holliganism. Have you noticed cans and bottles are invariably used by these youngsters? These are almost certainly obtained in supermarkets which are open to the public and have no supervision. Again, the public house gets the blame.

For the protection of our traditional public house and its customer we must seek an end to these blatant unfair practices.
